The *Coalition en faveur de l'équité salariale*, which includes the FIQ, is delighted at the decision by Michelle Courchesne, President of the *Conseil du trésor*, to drop all the sections of Bill 130 concerning the abolition of the *Commission de l'équité salariale* (CÉS) and its transfer to the *Commission des normes du travail* (CNT).

Since the announcement of the abolition of the CÉS on March 31, 2010, the *Coalition en faveur de l'équité salariale* has challenged the government on the importance of maintaining a structured independent commission that recognizes the value of women's work. All these collective efforts have finally prevailed.


