

On February 26, the Secrétariat intersyndical des services publics (SISP) made public a study



carried out by the *Institut* de recherche en économie contemporaine (IRÉC) which demonstrates that public services are beneficial for everyone and represent an

important vector for the redistribution of wealth.

Entitled Les services publics : un véritable actif pour les ménages québécois, la valeur redistributive de l'offre et de la consommation des services publics, this study establishes the value of services consumed by households and businesses. It also measures the redistributive effect of these services and impacts on reducing inequalities.
